Background/Summary: Council passed Ordinance 08-2711 in 2008, decommissioning the airport commission, establishing an airport manager, and appointing the City Manager those duties. In 2008, the City Council also passed ordinance 08-2692, amending the comprehensive plan for the airport property and creating a gateway district.

The airport property no longer exists as such, and the assignment of an airport manager is no longer required. Ordinance 19-2934 repeals BMC title 2, Chapter 2.78, Airport Manager in its entirety.

ORDINANCE NO. 19-2934

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BLAINE,
WASHINGTON, REPEALING MUNICIPAL CODE 2.78 – AIRPORT MANAGER**

WHEREAS, on February 26, 2007, the City of Blaine (“City”) City Council (“Council”) passed Ordinance No. 07-2658, providing for the permanent closure of the Blaine Municipal Airport by December 31, 2008; and

WHEREAS, on August 11, 2008, the Blaine City Council passed Ordinance 08-2711, decommissioning the airport commission and establishing an airport manager and assigning the City Manager the responsibility of managing and operating the municipal airport pursuant to 14.08.120 RCW; and

WHEREAS, on April 28, 2008, the Blaine City Council passed Ordinance 08-2692, amending the Blaine comprehensive plan of the airport property and creating a gateway district for the purpose of encouraging the development of safe and compatible mix of commercial, office and light industrial uses; and

WHEREAS, the Blaine Municipal Airport was closed effective December 31, 2008 and the City is no longer in need of an airport manager, nor the associated regulations found in Blaine Municipal Code Chapter 2.78, which should be repealed.

NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF BLAINE, WASHINGTON as follows:

Section 1: Blaine Municipal Code Chapter 2.78 – Airport Manager shall be repealed in its entirety.

Section 2: If any section, subsection, clause, or phrase of this Ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance.

Section 3: This Ordinance shall be in force from and after passage by a majority of the City Council.
