Background/Summary:

On January 6, 2020, the City received a check in the amount of \$20,000 from the Whatcom Community Foundation. The donor advised grant is a gift from the Stroum Family Foundation via the Whatcom Community Foundation and is specifically for unrestricted support of the Blaine Police Department. The purpose of the budget amendment is to formally recognize the gift and to supplement the Police Department’s 2020 budget with the \$20,000.

The amendment supplements the 2020 General Fund Police Department budget with a \$20,000 donor advised grant for unrestricted support to the Blaine Police Department.

ORDINANCE NO. 20-2942

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BLAINE, WASHINGTON, AMENDING THE 2020 GENERAL FUND (001) POLICE DEPARTMENT BUDGET WITH A DONOR ADVISED GRANT.

WHEREAS, the 2020 Budget was passed and accepted by the Council on December 9, 2019; and

WHEREAS, in January 2020, the City received a \$20,000 grant; and

WHEREAS, the grant is a gift from the Stroum Family Foundation via the Whatcom Community Foundation; and

WHEREAS, the grant is specifically for unrestricted support of the Blaine Police Department; and

WHEREAS, police department expenditures are accounted for in the City’s General Fund;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BLAINE, WASHINGTON, DOES ORDAIN AND AMENDS THE 2020 BUDGET AS FOLLOWS:

SECTION 1:

SECTION 2: Should any section, clause or provision of this Ordinance be declared by the courts to be invalid or unconstitutional, the same shall not affect the validity of the Ordinance as a whole, or any part thereof, other than the part of the Ordinance declared to be invalid.

SECTION 3: This Ordinance shall take effect and be in force from and after its passage by the City Council and approval by the Mayor, if approved, otherwise, as provided by law and five days after the date of posting for publication.
