Unified Fee Schedule Updates Background/Summary: Cemetery fees were last updated in 2017, and after a comprehensive review it was determined that adjustments needed to be made to the cost of cremains burials, as well as for niche wall interment, to ensure that the City is properly funding the Cemetery endowment fund for ongoing maintenance and upkeep of the Blaine Cemetery. Rates for cremains burial will be set at \$500, rates for niche purchase will be set at \$2,000, and rates for niche burial will be set at \$100. The Park and Cemetery Board reviewed the study and these changes prior to bringing them to Council. In 2021, Washington State started requiring all Police Officers to wear body cameras. This update and the accompanying rules and regulations mean that the Police Records Officer will need to review and redact footage for any Public Records Request asking for this footage. Due to the staff time required for these reviews, it was determined that a fee of 66 cents per minute of the employee's time should be charged to help cover these additional operational costs, with a deposit of 10% of estimated cost dueprior to request fulfillment. This figure is calculated directly from the salary of the employee(s) doing the required work. **Budget Implications:** Current Budget New Budget Request Non-Budgetary These changes will result in additional revenue to meet increased operating costs for the Cemetery and for the review of body camera footage for Public Records Requests. Recommendation: Staff recommends that Council adopt Resolution 1877-22, updating the Unified Fee Schedule for 2022, with changes effective March 1, 2022.
